## **Scholarship to be offered to students admitted in School of Engineering**

Students will be offered tuition fees of Rs. 37,500/- per semester after considering consolidated scholarship to the students of IU subject to fulfilling the following conditions:

- (i) Student will maintain minimum CGPA of 8.0 in all the semesters.
- (ii) Student will maintain minimum 75% attendance in all the courses of respective semester.
- (iii) Student will not get involved in any indiscipline/anti-university/anti-school activity or case.
- (iv) If a student cannot fulfill the condition (i) and/or (ii), will not be eligible to get the scholarship in next semester and will have to pay the full tuition fees as prescribed by the University at the time of admission.
- (v) The scholarship will be reinstated only after fulfilling the condition (i) and /or (ii).
- (vi) Student can avail the above mentioned scholarship if he/she is not getting any other scholarship.
- (vii) The decision and/or any change made by the management will be considered as the final.
- (viii) The above scholarship and all the related decisions made by the management and any dispute are subject to Mehsana jurisdiction only.
