(In pursuance of powers conferred upon Officer on special duty by the Fee Regulatory Committee (Technical) the following circular is issued.)

CIRCULAR

The process of determination of fee structures of the self-financed institutions running Technical Professional Courses as notified under the Act 02,2008 (Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees), for the period of 2023-24 to 2025-26 is in progress and is likely to be over in due course. However, with a view to facilitate the process of admission of students to the colleges or institutions, the Fee Regulatory Committee (Technical), by way of an interim measure, issues following directions.

The colleges or institutions listed in **Appendix-I** which have proposed an increase of more than 5% of their existing fee of 2022-23 for the next block period of 3 years i.e. 2023-24, 2024-25 and 2025-26, are permitted to charge as provisional fee as indicated in this **Appendix-I**.

This fee is purely provisional and on the basis of it the colleges or institutions will charge a Provisional fee from the students admitted in Academic Year 2023-24 for the First Semester. It will be subject to the final determination of the fee structures of such colleges or institutions. However, the students are requested to take specific note of the fee proposed by the colleges or institutions shown in **Appendix-I**.

Upon, completion of the fee determination process, the final fee structures of the colleges or institutions will be declared and that will be the final fee chargeable by the colleges or institutions and payable by the students. It is explicitly made clear that if the provisional fee is lower than the final fee, the student will pay the fee difference to the colleges or institutions and if the final fee is lower than the provisional fee then the colleges or institutions will refund the excess amount paid



by the students. This will be done in accordance with the directions that may be prescribed by the Committee in the final fee order.

The provisional fee is subject to any direction, circular, order or notification that may be issued by the Government of Gujarat, the Government of India, any Statutory or Regulatory Body or any Court of Law.
